KOBE'S DAUGHTER CAUSED HELICOPTER CRASH, BUT GOD HOLDS KOBE RESPONSIBLE

Most people don't know what goes on at the Judgment Seat of Christ. The LORD GOD has transmitted encrypted transcripts from Kobe's trial, so you can have the opportunity.

The crash caused damage to the helicopter, and witnesses on board says the craft was leaking oil, but with Ara gone, there was no one left with expertise to salvage the craft or save the eight lives remaining.

After the crash, all 9 killed were judged by God at the Judgment Seat of Christ. The Court found that Gigi caused the crash, but God held Kobe responsible for the 9 deaths because Kobe sat idly by and watched Gigi attack Ara but failed to intervene. The LORD said Kobe was a "sissy." The Court concluded that Kobe bent Gigi's allowing her to falsely believe that she was born key and entitled to reign. The Court said Gigi's sin was that she failed to submit to authority and 9 are dead, including Gigi herself, because of it. Gigi was put on her knees and made to watch Kobe burn in the lake of fire

"The lake of fire is the second death. Anyone whose name was not found written in the book of life was thrown into the lake of fire. (Revelation 20:14(b) – 15).

Gigi was saved and is now in the house of God being rehabilitated. Gigi is required to remain on her knees in God's house, as a condition of her salvation.
